Schooling at Larkin' Hill is only open to riders who are competent in their riding skills and are experienced in jumping cross-country obstacles. All riders must complete both the Acknowledgment of Rules, release of liability and medical release prior to using the property.

By signing this registration form, you agree to comply with all rules and regulations of Larkin' Hill and to be legally bound and responsible for your actions and your horse's actions.

RIDER'S ACKNOWLEDGMENTS

- I attest to my competency and riding ability as an experienced equestrian.
- I have read and signed the "Participant Agreement."
- I agree to accept all financial responsibility for damage or injury that my horse or I may cause or contribute to.
- I agree to exercise care, caution, and control while riding on the premises of Larkin' Hill.
- I agree to abide by the regulations as set forth in this document.

REGULATIONS

- Schooling is available by appointment only.
- Use of the facility is limited to a maximum of 2-hour sessions A.M. or P.M. paid horse/rider combination.
- A negative Coggins test is required and must be submitted prior to horse brought onto the property.
- Each rider must wear an ASTM/SEI certified helmet, a body protector, and a medical armband as specified in the United States Evening Association (USEA) rules.
- Each rider must have a designated trainer or instructor at least 18 yrs. of age while schooling. The trainer/instructor must sign a "Medical and Release of Liability" (registration form). The trainer/instructor may not be responsible for more than **four** (4) **riders** at any one time. Contact organizer if a trainer is required.
- The trainer or instructor must have an operable cell phone and he/she is responsible for monitoring the rider while schooling.
- Each rider is responsible to be aware of the presence of other riders and to coordinate the use of the jumps to prevent collisions and other unsafe conditions.
- Land owner reserves the right to excuse a rider from the property if, in their opinion, that rider or trainer is conducting him/herself in an unsafe or otherwise unacceptable manner. No refund will be issued to anyone excused from the property.
- Dogs must be leashed at all times. Any dog left at a trailer or vehicle must be likewise constrained.
- There will be no food on the grounds. Water will be available for horses and humans.
- At land owner's discretion, the course may be closed or schooling canceled due to adverse weather conditions.
- At land owner's discretion, some obstacles may be unavailable for use.

FEES

- The fee for XC school is \$50.00 per Pony Club member, \$75.00 per non-member. Payable at registration.
- A ground fee of \$40.00 must be paid per horse brought to the facility for non-schooling purposes.

 - Excessive use of a whip on any horse in a stall, runway, schooling area, show ring, or elsewhere on the competition/clinic grounds, before or during a competition, by any person. Any striking of the horse's head (on the poll and forward of the poll) with the whip shall be deemed excessive.
 - Inhumane treatment of a horse in a stall, runway, school area, show ring, or elsewhere on the event grounds by any person.

Any action(s) against a horse by a competitor or an exhibitor which are deemed excessive by Show/Clinic Management, in the ring or anywhere on the competition grounds may be punished by warning or elimination, as deemed appropriate by the Management.
